

Toyota Coffee Rave @ Laser Motor PJ

Terms & Conditions

1. The Toyota Coffee Rave @ Laser Motor PJ (the “Event”) is organised by UMW Toyota Motor Sdn. Bhd. (“Organiser”) together with its authorised dealer, Laser Motor Group, and appointed agencies, partners, sponsors, vendors, and service providers (collectively referred to as the “Affiliates”).
2. The Event shall be conducted in accordance with these Terms and Conditions, all applicable laws and regulations, and any additional guidelines, instructions, or requirements imposed by the Organiser from time to time.
3. These Terms and Conditions shall apply to all individuals registering for and/or attending the Event (“Participant” or collectively “Participants”) and shall be deemed accepted upon successful registration and/or participation in the Event.
4. Full details, updates, announcements, and any revisions relating to the Event may be communicated through the official Toyota Malaysia website, microsite, social media platforms, or other official communication channels designated by the Organiser.
5. For the purposes of this Event, the collection, use, disclosure, and management of any personal data or other information provided by Participants shall be governed by the UMW Toyota Motor Privacy Policy available at:

6. Participants are deemed to have read, understood, and accepted the Privacy Policy, which forms an integral part of these Terms and Conditions.
7. By registering for the Event, Participants agree to:
 - i. provide true, accurate, current, and complete information during registration;
 - ii. ensure that all submitted information remains accurate and up to date; and
 - iii. comply with all instructions, directions, rules, and regulations issued by the Organiser during the Event.
8. The Organiser reserves the right to refuse, suspend, revoke, or cancel any registration or participation at its sole discretion without assigning any reason whatsoever.
9. The Organiser reserves the right to amend, postpone, reschedule, interrupt, or cancel the Event or any part thereof at any time without prior notice. The Organiser and its Affiliates shall not be liable for any loss, damages, costs, or inconvenience incurred as a result of such amendment, postponement, interruption, or cancellation.
10. The Organiser reserves the right to amend or update these Terms and Conditions from time to time without prior notice. Continued participation in the Event shall constitute acceptance of such revised Terms and Conditions.

11. By participating in the Event, Participants grant the Organiser and its Affiliates the unrestricted right to photograph, record, film, or otherwise capture the Participant's likeness, image, voice, appearance, statements, and participation during the Event and related activities.
12. Participants further agree that such photographs, videos, recordings, and other media materials may be used, published, reproduced, distributed, displayed, edited, or exploited by the Organiser and its Affiliates for advertising, publicity, promotional, marketing, commercial, digital, social media, archival, or other lawful purposes in any media format worldwide without further notice, approval, or compensation.
13. Participants acknowledge and agree that the Organiser and its Affiliates may use the personal information submitted for purposes including but not limited to:
 - i. event registration and management;
 - ii. participant verification and communication;
 - iii. customer engagement activities;
 - iv. marketing and promotional communications; and
 - v. future Toyota campaigns, events, test drives, showcases, and related activities.
14. Participants acknowledge that the Event may involve loud music, lighting effects, vehicle displays, live entertainment, crowded areas, and other high-energy activities and environments. Participants attend and participate in the Event voluntarily and are responsible for taking appropriate precautions for their own comfort, safety, and wellbeing.
15. Participants who are sensitive to loud sounds, flashing lights, crowded environments, or prolonged standing are advised to exercise discretion before participating in the Event.
16. While reasonable precautions will be taken by the Organiser to ensure safety and security during the Event, Participants attend and participate entirely at their own risk.
17. To the fullest extent permitted by law, the Organiser and its Affiliates shall not be responsible or liable for any injury, illness, loss, damage, accident, delay, theft, death, or any other claim arising directly or indirectly from participation in the Event or attendance at the Event venue.
18. Participants shall be solely responsible for their own personal belongings at all times. The Organiser and its Affiliates shall not be liable for any loss, theft, or damage to personal property howsoever caused.
19. Participants are expected to conduct themselves in an appropriate, respectful, and lawful manner throughout the Event. The Organiser reserves the right to remove any Participant deemed disruptive, dangerous, intoxicated, offensive, unlawful, or otherwise unsuitable from the Event premises without compensation or liability.
20. The Organiser reserves the right to conduct reasonable security checks or inspections on any bags, belongings, or items brought into the Event venue where necessary.

21. Participation in the Event may be subject to venue capacity limitations, safety requirements, operational restrictions, or eligibility criteria as determined solely by the Organiser.
22. In the event of any dispute arising from or relating to the Event, the Organiser's decision shall be final, conclusive, and binding. No correspondence, appeals, or disputes shall be entertained.
23. These Terms and Conditions shall be governed by and construed in accordance with the laws of Malaysia.
